The Polk Inter-Agency Narcotics Team (POINT) recently concluded a four month long investigation into the illegal distribution of methamphetamine in and affecting the Polk County area. The investigation, dubbed Operation Deicer, developed as replaced resources in the county allowed for investigations into drug traffickers to be renewed.

POINT is a cooperative effort by the member agencies that includes the Polk County District Attorney's Office, Polk County Sheriff's Office, Dallas Police Department, Monmouth Police Department and Independence Police Department. 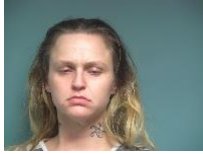
