Thomas-Rogers, age 30 of Washington, and found he had no insurance on the vehicle, a suspended driver's license and an active \$2500 warrant for PCS Heroin out of Multnomah County. The passenger, 28 year old Anthony A. Vielmetti of Gresham, was arrested and held on a probation detainer out of Multnomah County, as he is currently on supervision for Distribution of Heroin. The vehicle was impounded, upon completing a vehicle inventory heroin was found, along with over \$300 worth of stolen merchandise from a local retailer. Mr. Rogers was held on his warrant, and lodged at the Clackamas County Jail on charges of PCS Heroin, Theft II, and Criminal Possession of a Forged Instrument, a counterfeit \$50 bill. Mr. Vielmetti was lodged at the Clackamas County Jail on the probation violation detainer. Mr. Rogers was cited for operation without required lighting, driving while suspended, driving uninsured, and parking in a marked disabled parking space.
