Lincoln County was provided a large quantity of face coverings from the State of Oregon that can be distributed to the public and local businesses. The face coverings are disposable and are like a procedure mask, durable but not washable. The Chambers of Lincoln County have agreed to be your point of contact for this valued distribution.

If you need face coverings for your workforce, their family members and the clients, customers you serve then please follow the instructions below.

In addition to the face coverings, businesses can order face shields for their employees who cannot easily wear a face covering while performing their job duties – face shields are for employees only.
